## Meeting Minutes December 16, 2022

- 1. Approval of Minutes from November meeting.
  - a. Small corrections, minutes approved

(Bridget volunteered to take the minutes at the next meeting.)

- 2. FGL Discussion Senate Meeting Modalities
  - a. Some campuses drafted resolutions
  - b. Some campuses made use of the Trustees' resolution
  - c. Some schools that decided to do remote modality have had issues with quorum unlike Lehman; remote modality campuses have not resolved the "extraordinary circumstances" and simply allow people to log on if they need to attend virtually; in person quorum must be met, whether meeting is in person or hybrid. Concerns around voting has to be the same whether remote or in person difficulty figuring this out.
  - d. Discussion ensued on the open meetings law. Clarifications regarding in person quorum required, and resolution needing to have a plan for committees and subcommittees to have in person quorum as well. We also discussed the issue of access for voting Senators who have extenuating circumstances and are not going to Senate meetings. Since we are meeting quorum we are not considering a resolution to open meetings law. Discussion closed. Open meetings law excerpt was shared in the chat for reference:

A public body may, in its discretion, use videoconferencing to

- 41 conduct its meetings pursuant to the requirements of this article
- 42 provided that a minimum number of members are present to fulfill the
- 43 public body's quorum requirement in the same physical location or
- 44 locations where the public can attend and the following criteria are 45 met:
- (a) the governing board of a county, city, town or village has adopted a local law, or a public body has adopted a resolution, or the senate and assembly have adopted a joint resolution, following a public hearing, authorizing the use of videoconferencing:
  - (i) for itself and its committees or subcommittees; or,
  - (ii) specifying that each committee or subcommittee may make its own determination....
