- The application submission deadline is **Friday**, **December 15**, **2017**, **11:59 PM EST**.
- The award details remain the same and applicants should follow the Pilot Program Guidelines found on our website: <u>PSC-CUNY Research Awards Program</u>

Notification of the award results remains April 13th for Traditional A and B Awards and May 11th for Enhanced Awards. The budget period for Cycle 49 is July 1st, 2018 – June 30th, 2019.

Please note an attribute was added to the general application tab and applicants must now indicate if interviews will be conducted by selecting yes or no from the drop down box. This will help in identifying applications that require IRB review. If an applicant forgets their user ID/password they should not create a new ID, but contact the RF and the information will be forwarded to them.
