I also understand that I may be subject to disciplinary action.

• The colleges will not review any residency determination unless the request for the review is made in writing, and all required documentation is submitted on or before the last day of finals in the semester for which resident tuition is being sought.

The following is a list of the categories of non-immigrant aliens who under Federal law have the capacity to become City and State of New York domiciliaries and therefore may qualify for the resident rate of tuition provided they have established intent (see Subsection "H") and also satisfy the University's residency requirements in Subsection "A" above.

G	Certain government or international organization officials and their families
H-1B	Temporary worker in specialty occupation
H-1C	Temporary worker performing professional nursing services
H-4	Spouse or children of alien classified as H-1B or H-1C
I	Representatives of foreign information media and their spouse and children
K	Fiancé(e) or Spouse of a U.S. citizen and dependent children
L	Intra-company transferee (such as managers who have worked abroad for a branch of a U.S. firm) and their spouse and children
N	Parents and children of an alien granted permanent residency as a special immigrant
R	Religious workers and their spouse and children
S	Crime witnesses and their spouse and children
T	Victims of alien trafficking

In all cases, a student who has proven a valid immigration status must also meet the residency requirements outlined in this document (page 1). In addition, a student must intend to permanently remain in New York State and/or New York City (depending on senior or community college status) and not return to his/her prior domicile in order to qualify for the University's resident tuition rate.
