## 2010-2011 VERIFICATION WORKSHEET

Federal Student Aid Programs

## What is Verification?

Your application was selected by the U.S. Department of Education for review in a process called "Verification".

The Office of Financial Aid must compare information from your application with information you provide on this worksheet, signed copies of your 2009 Federal Income Tax Returns, including all schedules and W-2's and other financial documents. If you are married, you will need to submit your spouse's 2009 tax return. If you are considered dependent for Federal aid purposes, you will need to submit signed copies of your parents' 2009 tax returns. If there are differences between your application information and the documents you submit, your application may need to be reprocessed. Try to complete verification as soon as possible, so your financial aid won't be delayed. The Office of Financial Aid will not make any Federal financial aid payments available to you or process a student loan request until all verification requirements have been met and the necessary corrections have been made.

## What you should do:

- Collect signed 2009 tax returns (including all schedules, attachments and W-2 forms) for yourself, your spouse (if married) or your parents (if dependent).
- 2. Fill in this worksheet you and either your spouse (if married) or at least one parent (if dependent) must sign the certification.
- Review the last page of your Student Aid Report (SAR) to see if you need to submit other documentation (such as default clearance letters, citizenship documentation, social security card, etc.)
- 4. Take the completed worksheet, tax forms, and any other documentation to the Office of Financial Aid in Shuster rm. 136.
- 5. Upon review by a financial aid counselor, you may be asked to submit additional documentation or your application may have to be reprocessed. Once the process of verification is complete and any necessary corrections made, you will be notified about your financial aid award(s).
