*The extraordinary circumstances brought on by coronavirus have prompted CUNY to develop a Flexible Credit/No Credit Policy. This policy was approved by the CUNY Board of Trustees at their March 30, 2020 meeting. This policy will go into effect April 1, 2020.

Before choosing this grading option for one or more of their classes, students should consult with their academic and financial aid advisors regarding potential impacts to their financial aid, licensure requirements, and graduate school admissions.

Students will have 20 business days after the University's final grade submission deadline to decide if they want to convert the letter grades they earn in their classes to Credit/No Credit (CR/NC) grading.

A passing letter grade will receive a grade of 'CR', credit for the course, and no impact on the GPA. A failing grade (F) will receive a grade of NC and no impact on the GPA.

Students must remain in compliance with <u>Federal and State Satisfactory Academic Progress (SAP) guidelines.</u>
